FBA Constitution; Article 5; Section 5: The function of the Executive Committee shall be to serve, ad interim, to conduct business as is necessary between the fall Annual Meetings of the Association. The Executive Committee shall be comprised of the Pastors of the cooperating churches, plus one other person from each cooperating church who has been chosen and certified to the Association by the church as a resident and active member. Additionally, the elected officers of the Association shall be members of the Executive Committee. Each member shall be entitled to one vote.
